- Every Self-employed person in whom the Social Security Act and Regulations apply is required to register with the Director of Social Security within seven (7) days of the date of which he/she becomes self-employed.
- Any person who ceases to be self-employed or changes his/her business name or address, must notify the Director of Social Security.
- PENALTY** - If any person contravenes or fails to comply with any of the Social Security (Registration) Regulations, he/she shall be liable on summary conviction to a fine not exceeding one hundred dollars (\$100.00) for each such offence, or, where the offence consists of continuing any such contravention or failure after conviction thereof, to a fine of one hundred dollars (\$100.00), together with a further one hundred dollars (\$100.00) for each day of which it is so continued.
